### **HOW THE BUDGET PLAN WORKS**

#### *CONDITIONS OF BUDGET PLAN*

##### **NEW CUSTOMERS**

In order to qualify for our budget plan, we request that you have ordered at least one delivery of fuel and have paid for it on delivery prior to us setting up the budget pan. At this stage you will qualify for our payment plan. Simply fill out the following form and send it back to our offices;

Credit Control Department, Thomas Flynn & Sons Ltd, The Downs, Mullingar, Co. Westmeath

Two monthly payments will be taken from your account (end of month) prior to us activating your budget plan. The first order you place will be either capped to 500 litres or the value on your budget plan account.

There shall be no outstanding balances on all budget plan accounts on the 30<sup>th</sup> June and 31<sup>st</sup> January each year.

##### **DIRECT DEBIT DATE**

Payments must be in your bank by the 25<sup>th</sup> of each month. Please allow 5 working days for processing.

##### **MONTHLY PAYMENTS**

A minimum monthly payment of €\_\_\_\_\_ by direct debit is recommended, however your payments may be higher depending on your oil consumption during the budget year.

##### **PAYMENTS REJECTED**

If your direct debit is rejected for any reason, a fee of €15 will be charged to your account. However, if your direct debit is rejected three times, your budget plan will be stopped and your account must be paid in full within 30 days. If payment is not received within 30 days, interest will be charged.

##### **CANCELLATION**

Cancellations can be made at any time (all outstanding balances must be settled in full). In the event of your account being in credit, we do not offer a refund.

##### **REQUIREMENTS**

Proof of address & photo ID is needed.
